1. Purpose

2. Policy

2.1 Governing documents, policies and regulations applying to membership

Members of the Carlile Swimming Team will be bound by the Constitution and By-Laws of the organisation. From time to time the Directors of the Carlile Swimming Team will

endorse policies to assist with the operations and achievement of the objects of the Carlile Swimming Team.

2.2 Membership types

- Junior Swimmer Membership (6-17 years of age)
- Junior Non-Swimmer Membership (6-17 years of age)
- Life Membership

2.4 Membership fees and subscriptions

Members of the Carlile Swimming Team will be required to pay membership fees and subscriptions per annum as determined by the Directors of Carlile Swimming in accordance with clause 9.

The Directors will determine:

- The amount payable by an applicant for membership
- The amount payable by the member for any annual subscription
- Any other amount payable by a member
- The payment method and due date

2.5 Membership transfers

Members transferring into the Carlile Swimming Team from outside of the Heritage Club(s) will be liable to pay the Carlile Swimming Team Membership fee (without the Area/SNSW/SAL Affiliation Fee) should they have already been a member of another club during that membership period.

2.6 Working with children check

Individual Non-Swimming members joining the Carlile Swimming Team will be required to provide team management with a valid NSW Working With Children Check, including check number and expiry date at the time of registration. Throughout the period of membership with the Carlile Swimming Team it is the individual's responsibility to maintain a valid working with children check.

2.7 Heritage club second claim membership

Individual swimming members of the Carlile Swimming Team from Ryde will become a second claim member of Ryde-Carlile Swimming Club.

2.8 Parent/Caregiver membership

Swimming members under 18 years will require a Parent/Caregiver to become a fully paid member of the Carlile Swimming Team as either a Swimming or Non-Swimming member.

2.9 Member support of club activities

All members acknowledge that it is a requirement of membership of the Carlile Swimming Team, that they or their parent/caregiver/supporter assist with and contribute to the fulfillment of club obligations and the delivery of club activities from time to time.
